Billing Policy Outline:

With a Home Care Package (HCP), clients can receive funded services delivered either directly by CatholicCare, or by a third-party provider engaged through a brokered service agreement. Where services are delivered directly by CatholicCare, the following fees will apply. Alternatively, if services or goods are provided by external third parties then the client's HCP will be charged per the invoice provided.
